What data do we collect?

Our Company collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Via Blue Host, our web hotel, we see monthly statistics reflecting aggregated data of our visitors, but no
 information specific to your personal data. This is to understand whether we HAVE visitors, how many,
 and from what general area of the world.

How do we collect your data?

We collect data when you:

- Voluntarily complete a customer survey or send a message to us via our online form.
- Use or view our website via your browser's cookies.
- Via Blue Host, our web hotel, we see monthly statistics reflecting aggregated data of our visitors, but no information specific to your personal data
- We do not collect data via any other sources. If you are referenced to us via third party social media sites or personal contacts, we will enter your data based on your consent, which we will also retain on file until you ask us to remove your personal contact information.

How will we use your data?

Our Company collects your data so that we can:

- Manage a CRM database tool with names, phones, and emails as well as dates of contact.
- Email you on the basis of your preference, but not more than twice annually unless you are an active client.

TRANSMERA will not share your data with our partners without your explicit and separate permission.

If we enter into a business agreement-transaction, TRANSMERA reserves the right to send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent exchange of services.

How do we store your data?

TRANSMERA securely maintains your data on a computer within the company. That data does not lie in the cloud. TRANSMERA will keep your personal for two years. Once this time period has expired, we will contact you for permision to maintain your files or for confirmation to detle your data.

Marketing-Outreach

TRANSMERA may like to send you information about products and services of that we think you might like. This would be in the form of an email or snail mail communication, not more than twice a year.

You have the right at any time to ask TRANSMERA not to contact you as well as to delete your data from our files. We are a small company. Do not hesitate to call or email to ask us not to hold your data on file.

What are your data protection rights?

TRANSMERA would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request TRANSMERA for a copy of the information we have on file about you (your name, phone, email, mail address).

The right to rectification – You have the right to request that TRANSMERA correct any information you believe is inaccurate. You also have the right to request us to complete the information you believe is incomplete.

The right to erasure – You have the right to request that TRANSMERA delete/erase your personal data, at any time. This and other rights are important in the context of other companies and larger organizations. While we do not process, transfer, or share your data, you have the right to request a company to restrict or prevent these actions.

The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions. The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions. The right to data portability – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
